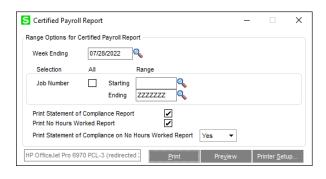

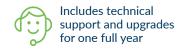

Versatile Compliance Reporting	Certified Payroll includes a host of reports designed to meet all of your contract compliance reporting needs. Reports include the Certified Payroll Report, Statement of Compliance, Certified Payroll Job Listing, Labor Contract Listing, Certified Payroll Report by Employee Sort Field, Fringe Benefit Report, and Monthly Employment Utilization (EEO) Report.
Statement of Compliance	Versatile setup options allow you to configure the Statement of Compliance form to include additional information as may be required by your reporting agency. Multiple copies of the Certified Payroll Report and individually addressed Statements may be produced when you utilize Job Recipient Maintenance. Exceptions are reported as required by the fringe benefit plan for each job.
